## General Terms:

Students are responsible for good behavior on school computers. General school rules for behavior and communications apply. Access to computers and network Is given to students who agree to act in a considerate and responsible manner. Parent permission is required. Access is a privilege - not a right. Access emails responsibility.

All computers and other technology are to be used in a responsible, efficient, ethical and legal manner. Christian values are to be honored when using the Internet. School computers are to be used for educational purpose only. No game playing is permitted on school computers, except for education software packages that use a game format. School computers are never to be used to access chat rooms or any other sites that allow multi-user Interaction. All computer usage must be supervised by the school staff/faculty.

Flies stored with the school computer systems should be limited to those relating to formal school courses or activities. Games, commercial software, or graphic files that are not for school projects or formal activity should not be used or stored In the school computer systems.

If the user makes changes to the system software, including administrative privileges, the user will be responsible for the consequences of those actions.

Through the course of the school year, movies/video may be shown that would serve as a supplement to classroom material or are of a character-building/spiritual nature. These movies are screened and approved beforehand. Students are to refrain from bringing video games or movies to school.

Students are not permitted to bring laptops, Gameboys, MP3 players, Xbox, headphones, or other electronic devices to school.

## Internet Usage:

Access to the Intern will enable students to explore thousands of libraries, databases, and bulletin boards throughout the world. Parents should be warned that some material accessible via the Internet may contain items that are Illegal, defamatory, Inaccurate, or potentially offensive to some people. While our intent is to make internet access available to further education goals and objectives, students may find ways to access other material as well. We will supervise and discourage any such behavior. We will guide them to appropriate materials. We endeavor to block inappropriate mater through content filtering software on the Internet. We believe that the benefits to students from access to the internet exceed any disadvantages. However, parents ultimately bear the responsibility for wetting and conveying the standards that their children should follow when using media and information sources. Families bear the same responsibility for such guidance as they exercise the Information sources such as television, telephones, movies, radio, and other potentially offensive media.
